The role requires strong functional expertise in FI/CO, hands-on experience with basic customizing, and the ability to collaborate with internal stakeholders and external service providers. The expert will translate business requirements into technical specifications, oversee implementation quality, and ensure successful testing and deployment of SAP solutions.

Your main responsibilities:

- Analyze business requirements and translate them into functional specifications for SAP FI/CO
- Perform basic customizing activities in SAP FI and CO modules
- Support and optimize existing SAP ECC6 and S/4HANA processes

- Coordinate and manage external consultants, including requirement clarification, quality assurance, and timeline monitoring
- Conduct functional and technical tests based on business requirements
- Support E-Invoicing processes via SAP Document and Reporting Compliance (DRC) across multiple countries
- Collaborate with cross-functional teams (SD, MM, PP) to ensure end-to-end process integration
- Provide 2nd-level support for SAP FI/CO incidents and change requests
- Document system changes, processes, and test results
- Participate in SAP projects, rollouts, and upgrades
